CHROMEBOOK:

Lander Valley High School issues a Chromebook computer for each student's exclusive use throughout their school years. This is a school-wide "one-to-one" initiative. We have seen increases in student engagement, and we have created a learning environment fostering critical thinking, collaboration, communication, and creativity. Students may still choose to bring their own device (BYOD), but LVHS will provide a Chromebook to each student who chooses not to bring their own device.

There are expectations the LVHS staff have regarding students and their devices. Parents need to also be aware of these guidelines and expectations for usage. DRIVING/PARKING EXPECTATIONS:

Driving at LVHS is a privilege and requires students to be a responsible driver. Students will be held accountable for following expectations and guidelines. Choosing not to follow the expectations could lead to a loss of driving privileges on the LVHS campus. LVHS authorities may search any motor vehicle operated by a student when parked on school property whenever school authorities have a reasonable cause to suspect the motor vehicle may conceal/contain illegal/unauthorized objects/materials. School authorities may take possession of any illegal/unauthorized object/materials found within the vehicle and may turn over any of the items to law enforcement officials under proper circumstances.

GRADES 10/11/12 ONLY (IF ELIGIBLE) ~ STUDENT LUNCH RELEASE:

Students must meet ALL academic requirements: 1) Must be on track to graduate on time, 2) Sophomores have a minimum 6.5 credits; Juniors have a minimum of 12.5 credits; Seniors, a minimum of 18 credits as the fall semester begins, 3) Students are passing current courses.

Sophomores/Juniors/Seniors will be allowed to leave campus during lunch as long as they meet ALL other behavioral expectations, including but not limited to: parking lot expectations, no attendance/behavioral violations throughout the school year, no complaints reported from community patrons, merchants or law enforcement during the lunch period, and no parking violations. Students will follow daily check-in and check-out procedures using student ID. ANY VIOLATION OF THE AFOREMENTIONED CRITERIA WILL RESULT IN LOSS OF PRIVILEGE AND PASS WILL BE CONFISCATED.

Dear Parent or Guardian,

The Food Service Department would like to notify you of how our cafeteria works at LVHS for students. LVHS is our only school that has the sale of Ala Carte items.

- Such items are **NOT** part of a regular school lunch. If your student does **NOT** have funds available, either money in their lunch account, or cash in hand, **they will not be allowed to purchase or charge any ala carte items.**
- A regular school breakfast cost \$1.80 per day. This includes; 1 entrée serving, fruits, grains & milk.
- A regular school lunch cost \$3.00 per day. This includes; 1 entrée serving, fruits, veggies, grains & milk.
- Ala Carte items range in prices from \$.25 to \$2.50 and include, but aren't limited to the following; the purchase of an extra entrée serving, granola bars, whole grain snack crackers, cheese sticks, yogurt, low-fat ice cream bars, frozen fruit bars, bottled water, bottled juices, etc.

Please discuss this with your student. We encourage you to view Parent Portal, to keep track of your students daily spending. You may also make payments online to your students lunch account via Parent Portal, but you can always send cash, check or money order to school. Credit/debit card payments may be made via your Parent Portal, at the schools front office or contacting the Food Service Director.

Lunch accounts that are more than 30 days negative may be turned over to a collection agency. Reduced and Free meals are available with qualifying application. This does not apply to reduce the cost of ala carte items, only on a regular school lunch or breakfast. Applications are available at any of our Lander schools, online through your Parent Portal or printable off of the district website at www.landingschools.org.
